## Revised DOR Policy

### *DOR= Deed of Restrictions*

The purpose of the DOR's is to help maintain high property values by preventing and providing a remedy for violations from the applicable set of restrictions for the Masterson Station Neighborhood. Homeowners are strongly encouraged to correct such violations in a timely manner in order to prevent monthly fines that will incur or further legal action that may take place. As of June 9th 2011, the DOR policy has been revised. MSNA directors hope that the newly revised edition will prevent repeat offenders from continuously breaking the rules. Generally, the first time a Board member or the Association's property manager becomes aware of the violation, the Association will send an initial "Notice of Violation" letter to the owner giving 10 days to remedy such violation. If the violation is not corrected within the allotted time frame; 10 calendar days from the date of the letter the homeowner begins to incur a monthly fine until the violation has been corrected. This time frame will be strictly enforced. The fining schedule breaks down according to the type of violation. ## Proper Storage for Trash Containers

### REVISED

In 2010 LFUCG passed an amendment to the City Ordinance pertaining to the proper storage of Herbies. Herbies now shall be placed at the curb between 4PM on the evening before collection and shall be removed by 7PM on the day of collection. Containers will be kept either in the rear yard or in the side yard when not located on the curb. **DO NOT STORE your Herbies in the FRONT OF YOUR GARAGE.** Civil fines will be assessed for the continuous roll cart violations. MSNA will be noting violations of such improper storage of Herbies and violations will be reported to LexCall.

Setting your roll-cart or bulky items on the curb at the wrong time or improperly preparing bulky items are violations of Lexington's solid waste ordinances. Property owners who receive a violation from the Division of Waste Management must now correct the violation within 48 hours. Failure to correct a roll-cart violation within 48 hours can result in the issuance of civil penalties of up to \$100 and improper set-out of bulky items can result in civil penalties of up to \$600.

\*\*This policy is one that will be strongly enforced under the DOR's for Masterson Station. The storage habits for Herbies and Rosies will be monitored on a weekly basis upon neighborhood inspections.

You must obtain a permit from the city for a fence and submit your plans to the Association for approval prior to installing your fence/shed. For fence and/or shed guidelines you can download an application from our neighborhood website or please contact our Property Manager and one can be sent to your home.*

## CERT

Do you know what you would do in the immediate aftermath of a disaster? What if you were on your own for a while before professional first responders could get to your neighborhood? Community Emergency Response Teams (CERT) training teaches you just that— how to preserve life, property and the environment until the professionals can get to you.

The next CERT training is scheduled for September and is taught by the Divisions of Environmental and Emergency Management and Fire and Emergency Services. The training consists of eight three– hour sessions spread over the course of two months. In these sessions you will learn about general disaster preparedness, fire safety and suppression, disaster medical operations, light search and rescue, team organization and the Incident Command System, disaster psychology, terrorism and weapons of mass destruction. The last session is a simulated disaster exercise where the teams get to practice what they learned in the previous eight sessions.

## STREET TREE CARE

Many residents are not aware that they are responsible for maintaining the street trees on their property. This includes pruning or trimming any tree branches that hinder a 7-ft. clearance on the sidewalks and a 12– ft. clearance above street traffic (14– ft. for main roads such as Masterson Station Dr. and Sandersville Rd). It is also just as important to remove any that are below the 7– ft line to insure proper tree health and growth. Our Accounts Receivable Policy can be found on the Masterson Station Neighborhood website. There are some owners who owe not only current dues, but also past year's dues. If your dues are not paid in a timely manner, we will be contacting our attorney to file a lien on your property in order to collect, which will also increase your amount owed by at least \$250 this year.
